Guidelines for Mid Term Online Examination:

1. The Mid Term Examination of B.A.LL.B. (Hons.) Semester 1st (fresh) and Semester 3rd and 5th commencing w.e.f. 10.01.2022 shall be Online.
2. The duration of the mid-term examination shall be 1 hour 30 minutes including the time to scan the answer scripts and each paper shall be 20 marks.
3. The question paper shall be divided into three sections: Section-A:- There shall be a compulsory question of 4 parts taken from two modules. Each part shall carry 2.5 marks. Section B & C shall have two questions and students shall attempt any one question from each section. Each question shall carry 5 marks.
4. The Question Paper will be uploaded 10 minutes before the scheduled time for downloading of Question paper at onlineexam.dbranlu.ac.in.
5. The students can download the Question Paper through login with his/her University Roll No. and Date of Birth.
6. The Stamped Front Page of the Answer Sheet will be available for the students at the examination portal of the University and must be attached with a scanned copy of the answer script.
7. In case of any problem faced by the students, they are required to mail their request narrating the nature of the problem in this regard at inchargelaw@dbranlu.ac.in
8. The students are advised to attempt the questions as per instructions mentioned in the Question Paper.
9. The students are required to do page markings on each page of the Answer Sheet.
10. The students will ensure their presence before the camera of the Laptop/PC during the examinations and not switch it off in any case; otherwise, Unfair Means and Misconduct cases shall be registered.
11. The students are required to put their signatures on every page of the Answer Sheet.
12. Students are required to scan their answer script and the same are to be e-mailed on the e-mail address provided to the student.
13. Only one scanned file of the whole answer script is to be e-mailed.
14. The name of the scanned file shall be Roll No. _ Paper code (eg. 1901001_501) for economics.
15. Students are strictly advised not to write anything in the main body of the e-mail.
16. The subject of the e-mail shall be the same as the name of the file attached. i.e. Roll. No_Paper code.
17. No extra time will be given to students to scan the answer script.
18. In case the above-mentioned instructions are not followed by the students his/her answer script will not be evaluated and no further representation will be entertained in this regard afterward.
19. After completion of answers, the students must draw a line and write the *End of Answer Sheet*.
