**NOTIFICATION**

The Executive Council under Section 13(d) of the University Act has considered and approved the recommendation of the Finance Committee on the matter of waiver of fee arise out of COVID-19 and order of the Hon'ble Punjab and Haryana High Court in CWP No. 26123/2021 titled as Raghav Gupta Versus Dr. B.R. Ambedkar National Law University and others as under:

1. (i) The amount of fee to be charged under the heads Hostel Rent (Double Occupancy) and other charges, Health and Sports Facility, Amenities Fee and Advance Mess bill adjustable against actual bill against each student till continuation of COVID-19 situation or return of the students to the Campus is waived off. The waiver amount is as under:
  - (a) Hostel Rent (Double Occupancy) and other charges: Rs. 40,000/-
  - (b) Health and Sports Facility: Rs. 15,000/-
  - (c) Amenities Fee: Rs. 5,000/-
  - (d) Advance Mess bill adjustable against actual bill: Rs. 30,000/-
- (ii) Likewise, the previously suspended amount under these four heads to be charged during the academic session 2020-21 is also waived off. The waiver amount is as under:
  - (a) Hostel Rent (Double Occupancy) and other charges: Rs. 40,000/-
  - (b) Health and Sports Facility: Rs. 15,000/-
  - (c) Amenities Fee: Rs. 5,000/-
  - (d) Advance Mess bill adjustable against actual bill: Rs. 40,000/-
- (iii) The total amount waived off under these four heads is Rs. 1,00,000/- per student during academic session 2020-21 while it is Rs. 90,000/- per student during academic session 2021-22. The cumulative amount for the academic session 2020-21 is Rs. 2,44,00,000/- and 2021-22 is Rs. 3,21,30,000/- i.e. Rs. 5,65,30,000/- for both the sessions.
- (iv) To maintain the uniformity, an amount of Rs. 3,000/- under the head Moot Court Fee shall be recovered/demanded from the newly admitted students of the academic session 2020-21 (1st Year).
- (v) When the students resume in the Campus, they shall be charged under all these heads from the very date.
- (vi) the amount deposited under above mentioned heads (if any) will be adjusted.
